The paper presenters should send their duly filled in application form (available at [www.iffraa.com](http://www.iffraa.com)), identity card issued by the college/university, abstract (*not more than 300 words*) & full paper (*not more than 4000 words in MS WORD, Times New Roman, font 12, spacing 1.5, justified with no page numbers and no page borders, word limit includes foot notes*), within 30<sup>th</sup> May 2020 to [submit@iffraa.com](mailto:submit@iffraa.com).

**CITATION**-Any uniform mode of citation is accepted, footnotes should be used, and end notes are not allowed.

Papers will be peer reviewed by members of the committee & other independent reviewers and will be published in the online journal with ISSN number.

Once the paper is accepted by the Editorial Board, the registration process will begin. Authors need to complete the registration process by paying the **requisite fee; the mode of payment will be intimated via mail. (Google pay/Paytm/Online Banking)**
