The charge-sheet against 15 accused persons is filed and cognizance is taken of. The present supplementary charge-sheet is filed against three accused persons namely Sharjeel Imam, Umar Khalid and Faizan Khan.

The sanction for prosecution under Section 45 of the Unlawful Activities (Prevention) Act, 1967 for offences under Section 13/16/17/18 of the said Act has been filed. The sanction under Section 196 Cr.P.C is stated to be pending and would be placed as and when received from the competent authority.

accompanying and of the charge-sheet perusal documents, there is sufficient material to proceed against accused persons namely Sharjeel Imam, Umar Khalid and Faizan Khan for offences

mentioned therein except for offences under Sections 124A/153A/109/120B of IPC for which necessary sanction is awaited.

Regarding offences under Section 124A/153A/109/120B of IPC, the same is deferred for the want of requisite sanction.

Since two accused persons namely Sharjeel Imam and Umar Khalid are present today with their counsels through Webex app, hence, there is no need to issue summons.

At this stage, Ld. Counsels for accused persons Sharjeel Imam and Umark Khalid submit that there is no necessity of issuing formal summons as they are present in the court through Webex and accepted notice.

Let summons be issued to accused Faizan Khan, who is on bail, through I.O for next date i.e. 22.12.2020.

Ld. Special Public Prosecutor submits that he has no objection if the court passes order for supply of soft copies of the charge-sheet in the form of Pendrive to the accused persons.

On the issue of compliance of Section 207 Cr.P.C regarding supply of the hard-copy of the charge-sheet, the State has already gone in appeal before Hon'ble High Court of Delhi which has, vide order dated 10.11.2020 passed in Crl. M.C. 2119/2020 & Crl. M.A 15099/2020, stayed the trial of this case. Awaiting the orders by Hon'ble High Court of Delhi, let the accused persons namely Sharjeel Imam, Umar Khalid and Faizan

Khan be supplied soft copies, in the form of Pendrive, of the entire chargesheet including the supplementary charge-sheet while the soft-copy of the supplementary charge-sheet be supplied to rest of the accused persons in the form of Pendrive.

There is no clarity whether the Pendrive is being allowed into the Jail or not.

Let copies of the charge-sheet in compliance of Section 207 Cr.P.C through Pendrive/soft copies be done on 02.12.2020 and counsel for accused persons may visit the court between 12.00 Noon to 2.00 PM for collecting the said copies. I.O shall also be present at the said time.

All accused persons who are in judicial custody be produced from concerned Jails on next date of hearing through Webex.

Copy of the order-sheet be also mailed to all the parties i.e. counsel for applicant/accused, Ld. Prosecutor and IO.
