Subject: Representation Letter requesting issuance of a direction to the Economic and Cybercrime Department (Bihar Police Headquarters) to withdraw its order dated <u>21.01.2021</u> inviting police action for posts against govt, elected representatives on social media.

Your Lordship,

I am Saurav Narayan, resident of Subhash Nagar, Hajipur, Vaishali, Bihar <u>844101</u> and I am currently pursuing law from Law Centre-1, Faculty of Law, University of Delhi.

This letter is in reference to the subject above stated with regard to the impugned order of the Economic and cybercrime Department (Bihar Police Headquarter) number 13/2021/विविध/गामा-1/साईबर/आ०अप०ई० dated 21.01.2021 which states "offensive, indecent and fallacious Social media posts against government, ministers, MPs, MLAs and govt officials will invite action by Bihar police". This order creates a chilling effect in the minds of citizens while making constructive criticism or offering important comments on the social media.

Although, the government of Bihar follows the principle of "Development with Social Justice" but the Economic and Cyber Crime Department evidently doesn't reflect it in their actions.

How can any state develop without allowing citizens to register their Dissent? In fact dissent is the essence of Democracy and not treason.

As Justice Deepak Gupta former Judge of Supreme court of India had stated so importantly that Suppression of dissent has a chilling effect on democracy.<sup>1</sup>

"The right to dissent is one of the most important rights guaranteed by our Constitution. As long as a person does not break the law or encourage strife, he has a right to differ from every other citizen and those in power and propagate what he believes is his belief."<sup>2</sup>

The hon'ble Supreme Court and the High Courts have zealously discharged the duties of "protector of fundamental rights of citizens" endowed by the ever so reverential constitution, whenever called upon to do so. It is with this firm faith, belief and devotion I would like to quote Nariman J. that suppressing dissent will have "chilling effect" on the freedom of speech. I, in my utmost conscience cannot evoke a better response against the matter instant pleaded.

Shreya Singhal vs. Union of India<sup>3</sup>

"In point of fact, Section 66A is cast so widely that virtually any opinion on any subject would be covered by it, as any serious opinion dissenting with the mores of the day would be caught within its net. Such is the reach of the section and if it is to withstand the test of constitutionality, the chilling effect on free speech would be total."

"The very essence of democracy is that every citizen has a right to participate not only in the electoral process but also in the way in which our country is run. This right becomes meaningless if that person cannot criticize the Government."

There can be no democracy without dissent. Recently, Justice D.Y. Chandrachud in his speech put the matter very succinctly. His lordship stated

"The blanket labelling of dissent as anti-national or anti-democratic strikes at the heart of our commitment to protect constitutional values and the promotion of deliberative democracy".

## ANTI - GOVERNMENT SOCIAL MEDIA POSTS A CYBERCRIME SINCE 21.01.2021

The Economic and cybercrime Department (Bihar Police Headquarter) number 13/2021/विविध/गामा-1/साईबर/आ०अप०ई० dated 21.01.2021 which states "offensive, indecent and fallacious Social media posts against government, ministers, MPs, MLAs and govt officials will invite action by Bihar police".

This order is unconstitutional as it clearly violates freedom of speech and expression which is enshrined in Article 19(1)(a) of Indian constitution.

It is the police itself which will judge which post is offensive for it and which is not, and hence it will have immense powers to arrest and detain anyone for his or her social media which doesn't portray the govt in good light.

As a Law student and a responsible citizen of India, I urge and implore your lordship to take steps as you deem fit to serve the public, by upholding the values of free speech enshrined in the Constitution of India as a fundamental right.

I end with a poem of Rabindranath Tagore.

Where the mind is without fear and the head is held high;

Where knowledge is free;

Where the world has not been broken up into fragments by narrow domestic walls; Where words come out from the depth of truth;

Where tireless striving stretches its arms towards perfection;

Where the clear stream of reason has not lost its way into the dreary desert sand of dead habit;

Where the mind is led forward by thee into ever- widening thought and action Into that heaven of freedom, my Father, let my country awake.
