

# ABOUT RAJIV GANDHI NATIONAL UNIVERSITY OF LAW, PUNJAB

Rajiv Gandhi National University of Law (RGNUL), Punjab, was established by the State Legislature of Punjab by passing the Rajiv Gandhi National University of Law, Punjab Act, 2006 (Punjab Act No. 12 of 2006). The Act incorporated a University of Law of national stature in the State of Punjab, thereby fulfilling the need for a Centre of Excellence in Legal Education in the modern era of globalization and liberalization. RGNUL started functioning from its temporary Headquarters - Mohindra Kothi, The Mall, Patiala w.e.f. 26 May, 2006. The University acquired approval of the Bar Council of India (BCI) in July 2006. The University also got registered with the University Grants Commission (UGC), New Delhi under Section 2(f) of the University Grants Commission Act, 1956 and has been declared fit to obtain grant from the University Grants Commission under Section 12- B of the UGC Act, 1956. The University has been accredited with 'A' grade by NAAC. The University has started functioning at its permanent Headquarters in Village Sidhuwal on Bhadson Road from 1st July 2013 in an area of 50 acres.

The University is dedicated to provide holistic legal education and to promote quality research in law and allied disciplines. Over the years, it has addressed a large number of contemporary social issues and invested a lot of innovative thinking in its instructional and research programmes. Towards this, it always welcomes collaboration with reputed institutions and organizations so as to build a platform for interchange of ideas on vexed social issues and problems confronting the society.


RGNUL has a well-equipped computerized Central Library with about twenty one thousand titles in addition to the specialized libraries of the various Research Centres. There are three advanced Computer Labs comprising of Apple, Del and HP computers and leased line Internet connectivity. The University is fully residential with boys and girls staying in separate hostels. The entire RGNUL Campus is Wi-Fi enabled which is also extended to the respective hostels round the clock.



The University has also set up a number of Centres of Excellence on its campus. These are Centre for Advanced Studies in Criminal Law (CASCL); Centre for Consumer Protection Law and Advocacy (CCPLA); Centre for Advanced Study in International Humanitarian Law (CASH); School of Agricultural Law and Economics (SALE); Centre for Advanced Studies in Human Rights (CASIHR); RGNUL Legal Aid Clinic (RLAC); RGNUL Enabling Unit (REU); RGNUL Institute of Competitive Examination (RICE) and Directorate of Distance Education (DODE). The objective of these centres is to undertake advanced study and research in the emerging areas of the respective fields, independently or in collaboration with various professional institutions at the national and international levels; to bring about publications and produce study material in the respective fields of knowledge; to organize seminars, workshops and conferences on contemporary and significant issues.

RGNUL has established a programme study centre of IGNOU, i.e. the School of Law (SOL) in its premises as well. The Study Centre was established at RGNUL in the year 2009. It runs various Post Graduate Diploma Programmes in diverse fields of Law. These courses are undertaken as distance education programmes and are run through the Programme Study Centres of IGNOU. The diplomas and courses are conducted with professional expertise and administrative support. At present, many students, professionals, administrators, researchers, lawyers, etc. from all over the northern zone are enrolled with the School of Law under various academic courses.

In a short span, RGNUL has also become a member of a number of professional organizations of national and international stature like the Asian Law Institute (ASLI), Singapore; Commonwealth Legal Education Association (CLEA), London; Forum of South Asian Clinical Law Teachers (FSACLT), Goa; Indian Economic Association (IEA), New Delhi; Indian Institute of Comparative Law (IICL), Jaipur; Indian Law Institute (ILI), New Delhi; Indian Political Science Association (IPSA); Indian Society of Criminology (ISC), Madras; Indian Society of International Law (ISIL), New Delhi; Institute of Constitutional and Parliamentary Studies (ICPS), New Delhi; International Association of Law Schools (IALS), United States of America; and International Law Students Association (ILSA), United States of America, Legal Information Institute of India (LII of India) etc.

Innovation and Startups in the legal field are the answer to this paradox that our Judicial System is facing. Many young entrepreneur have introduced startups which have come up in the legal system in the past few years especially by young, dynamic individuals. Also, the Ministries, Government Departments /bodies have initiated various innovative schemes for ensuring Justice is served to people at large.

Keeping the spirits of our vision in mind we at RGNUL, Punjab in association with Legal Startups is going to organize a unique National Competition on Legal Innovation & Legal Startups. We appeal and encourage young generation to present their existing startups/initiatives in the competition.

The competition is structured on the basic idea that we need to boost the morale of the people engaged in thinking out of the box and innovate in the proecess of reducing the work load of the courts. This competition will not just identify but also support those start ups which have a positive impact on the problems and the challenges faced by the judicial system.

# GUIDELINES OF THE COMPETITION

- ❖ Only existing Startups/Initiatives are allowed to participate in the competition. Startup/Initiative must be at least one year old but not more than three-year-old from the date of announcement of the competition.
- ❖ The competition is open to all individuals who are 18 years of age or above on the date of release of the competition.
- ❖ Participation is allowed only as a team. The team will consist of a minimum of two and maximum of four members.
- ❖ There is a registration fee of **Rs. 1180/-** (inclusive of GST) for participation by **Tuesday, August 29, 2021**.

- ❖ Registrations are to be done through the Google form by **Tuesday, August 29, 2021**. The link for the same can be found [here](#).
- ❖ Only selected entries will be invited to present their startup idea/initiative ideas. The shortlisting of the teams will be done by a Panel of Experts constituted for the same.
- ❖ After the shortlisting, there will be 2 rounds in the competition, preliminary and final. The preliminary round will be conducted on **Friday, October 1, 2021**, and the Final on **Saturday, October 2, 2021**. Both the rounds will be conducted through the Online mode. The top 5 teams will proceed to the final round. 50% of the Marks obtained in the Preliminary round will be carried forward. The Finals shall be adjudged on the basis of research undertaken, steps of implementation, methods adopted for improvisation, application success, Novelty as parameters, and presentation. The teams will be adjudged according to these parameters.
