
GEETA INSTITUTE OF LAW

The above list of sub-themes is not exhaustive and other contemporary issues related to the main theme can also be opted to write upon.

COMPETITION RULES:

- 1. Eligibility: Students (i.e. under and post graduate), research scholars, legal professionals and others interested in social sciences are eligible to participate.
- 2. Co-authorship of one is allowed.
- 3. Article should be the original work of the participants and must not exceed 6,000 words (including footnotes). The language of the articles should be English. Any kind of plagiarism will result in immediate disqualification. Bluebook 19 th edition should be adhered to for the purpose of citations.
- 4. The submission should only in "doc. or docx." format.
- 5. Submission should strictly follow the following rules:

Font - Time New Roman, Font size- 12, Line spacing- 1.5, Alignment-Justified

6. E-Certificates will be provided to all participants.
