## ABOUT THE EVENT

The IMS Unison University, Dehradun is organizing 3rd Edition of National Mediation Competition 2022 on 29th September to 01st October 2022. Law Universities / Colleges / Institutes across the country are invited to participate in the competition and to be a part of this most respected and awaited competition in India. The competition is considered as a flagship event of IMS Unison University Dehradun which will provide a real-life enriching experience of mediation.

The mediation competition is similar to mediation running before a Mediator assigned by the Court. When the court decides that there is a scope of settlement in the matter pending before him and the parties of the suit are agreeing for that, the court forwards the matter before the Mediator. The Mediator, to resolve the matter and to bring about a settlement between the parties, holds the meeting. In the Mediation competition, it is judged that what types of tools, techniques and manners are adopted by the participants as Mediator. The problem is henceforth based on Family law, Law of Contract and Sale of Goods Act. Maximum 25 teams are invited on the basis of first come first serve. The event will be conducted in four rounds i.e., Preliminary Round, Quarter Final Round, Semi-Final Round and Final Round.

We are proud to host this prestigious competition as it is going to be one of its kind and it shall be our utmost duty to put in our sincere efforts in aggrandizing the overall experience of the competition and hospitality for the participants, thus, striving to make this event a magnificent one.

### SUBJECTS ENCOMPASSED

All the Problems shall be based on either of the subjects, solely or in combination there with:

- Family law
- Law of Contract
- · Sale of Goods Act

## ELIGIBILITY CRITERIA

The Competition shall be open for 'bona-fide' students who are pursuing LL.M. Programme or Integrated Five-Year LL.B. Programme or Three-Year LL.B. Programme from any Institute/University in India. Such Institute/University must be recognized by the Bar Council of India.

## LANGUAGE

The language for each round of Competition shall be English only.

## DRESS CODE

A. Inside the Mediation Session the participant shall follow the below mentioned formal dress code.

- Female Participants: White Kurta, Black Salwar and Black Dupatta or White Shirt, Black Trousers and Black Tie, Black Coat and Black Leather Shoes.
- Male Participants: White Shirt, Black Trousers and Black Tie, Black Coat and Black Leather Shoes.
- B. The dress code for all the functions at the competition shall be Western Formals for Gentlemen and Western or Indian Formals for Ladies.
- \*All participants are mandatorily required to carry their University/College ID Card.

## **TEAM COMPOSITION**

- ☐ Team shall comprise of only two (2) members. One shall be Mediator and one shall act as a Client.
- □ Each Law Institute/ University shall be eligible to send Two Teams. Team should not disclose the identity of their Institution/University in course of proceedings in the mediation rooms; such disclosure shall invite penalties including disqualification.
- □ Each Team shall be provided with a separate team code at the time when its registration will be confirmed by organising committee.

## REGISTRATION

- Maximum 25 Teams shall be registered on first come first serve basis by properly filled
   Registration Form as provided in Google Link and submit Registration Fee.
- □ Registration fee 1800/- shall be submitted through NEFT/RTGS in the account of university.

## ROUNDS FOR MEDIATION

There shall be Preliminary, Quarter Final, Semi-Final and Final Round spreading over a period of 03 days.

#### A. DRAWOFLOTS

- The draw of lots for Preliminary Round shall take place after the physical registration in moot court room.
- To ensure unbiased selection, Teams shall be subjected to drawing of lots for the Preliminary Rounds.
- No changes shall be entertained in any circumstances after the draw of lots.
- The participating team will ensure their presence at the time of draw of lots. If the team is not
  present at the time of draw of lots then their escort member, allotted by organizer, represent
  the participating team for drawing the chit and the result of such draw of lots shall be
  binding over the participants.
- Each mediator will be provided with a client of different team (to avoid any biasness).

#### **B. PRELIMINARY ROUND**

- Every mediator of a Team will participate once in a round but the client of each team will
  appear two times in each and every round. First time he appears as a petitioner/plaintiff and
  second time as a respondent/defendant. This rule is applicable in all rounds of event except
  the final round.
- To qualify this round, the criteria of marking are aggregate total of the marks of both the mediator and the client.
- Top eight Teams will move to Quarter Final Round on the merit basis.
- In case of tie between the teams, it will be decided through Question-Answer Session.
- There shall be 20 minutes and 5 minutes (Caucus time) for Preliminary Round in which mediator will try to resolve the dispute, and prepare settlement agreement, upon which parties of dispute agrees in 10 minutes.

#### C. QUARTER FINAL ROUND

- Eight (8) Teams shall compete in this round.
- The draw of lots amongst these Eight Teams for Quarter Final Round will be conducted immediately after the result declaration of Preliminary Round.
- Four teams will move to Semi Final Round on knock out basis.
- In case of tie between Teams, it will be decided through Question-Answer Session.
- There shall be 20 minutes and 5 minutes (Caucus time) for Quarter Final Round in which mediator will try to resolve the dispute, and prepare settlement agreement, upon which parties of dispute agrees in 10 minutes.

#### D. SEMI FINAL ROUND

- Four Teams in Quarter Final Round will move to Semi Final Round on knock out basis.
- · The draw of lots amongst these Four Teams for Semi-Final Round will be conducted

immediately after the result declaration of Quarter Final Round.

- In case of tie between Teams, it will be decided through Question-Answer Session.
- There shall be 35 minutes and 10 (Caucus time) minutes for Semi Final Round in which
  mediator will try to resolve the dispute, and prepare settlement agreement, upon which
  parties of dispute agrees in 10 minutes.

#### E. FINAL ROUND

- Two Teams of Semi-Final Round will move to Final Round on knock out basis.
- The draw of lots amongst these Two Teams for Final Round will be conducted immediately
  after the result declaration of Semi-Final Round.
- There shall be 45 minutes and 15 minutes for Final Round in which mediator will try to resolve the dispute, and prepare settlement agreement, upon which parties of dispute agrees in 15 minutes.

## **SCOUTING**

- Teams shall not be allowed to observe the Rounds of any other Teams whatsoever.
- Scouting is strictly prohibited as per the Rules of the Competition.
- Scouting by any of the Teams shall entail instant disqualification.
- Any Team can file a written complaint to the Organising Committee for the same and the Organising Committee's decision regarding scouting shall be final.

## **AWARDS**

Best Team

The winning Team will receive a trophy and a cash prize of 5000/- and a certificate of merit.

Runners-Up Team:

The 1st Runners-up team will get a trophy and a cash prize of 4000/- and a certificate of

Best Student Mediator:

Best student mediator will get a trophy and cash prize of 3,000/- and a certificate of merit.

Best Student Client:

Best student client will get a trophy and cash prize of 3,000/- and a certificate of merit.

## ACCOMMODATION & FOOD

- The university will not provide the accommodation. A list of hotels will be recommended by the organizing committee to which university has tie up and as per their requirement; committee will hold the rooms in such hotel.
- University will provide breakfast, lunch and high tea from 29th September to 01st October, 2022.

## **MISCELLEANOUS**

- During the course of various rounds, the participants will not be permitted to make any audio/visual representation, nor will they be allowed to use personal computers, laptops and any other technical or mechanical device.
- In the support of their argument, the participants can produce the documents, if he asked to do so.
- If at any instance a submission is made with any material in violation to the above clause, the teams shall be disqualified from the competition forthwith.
- During the course of the entire round no mediator/client shall neither reveal his/her identify nor the identity of their University/College by any means whatsoever.
- The decision of the Judges as to the Marks secured by any Team shall be final.
- No Team or any of its members or anyone connected with any Team will be permitted to sit
  or hear the arguments in any Mediation Room in which that Team is not one of the
  contesting Teams. For the violation of this rule strict action may be taken against the team,
  even ranging to the disqualification of the team from the competition
- The Organizing Committee shall have the exclusive right pertaining to all and any issues
  related to the National Mediation Competition 2022. The decision of the Organizing
  Committee shall be final and binding and no team or participant whatsoever shall have any
  right to challenge the same.
- In the case of any dispute, Participants can file a written complain to the Organizing Committee and the decision of the Committee, subject to the revision by Dean, School of Law, IMS Unison University, shall be final.
