## SUBMISSION GUIDELINES

1. All submissions have to be in English.
2. The abstract should not be of more than 500 words. It shall be accompanied by a cover letter containing - a brief profile of the author including e-mail ID, contact number, designation, institution and official address.
3. Word limit for full research paper 4000-6000 words (inclusive of all citations and references).
4. Submissions must be typed in Times New Roman, Font Size 12 on A4 size paper with 1" margin on all sides with 1.5-line spacing. Heading should be in Times New Roman, Font Size 14, Bold, 1.5-line spacing, center aligned while sub-heading should be in Times New Roman, Font Size 13, Italicized, 1.15-line spacing. Footnotes must be in Times New Roman, Font Size 10 with 1.0-line spacing. The file extension shall be .doc.
5. There can be a maximum of only one Co-Author. All the co-authors need to get registered for the seminar.
6. Plagiarism shall not exceed more than 10%.
7. The Author(s) should also send a declaration along with the abstract & final paper that their work is original and unpublished and that it does not infringe the copyright laws. The organizing committee is not responsible for any copyright infringements by the authors and if found the paper is liable to be unqualified at any stage.
8. Author(s) are required to adhere to a uniform mode of citation **20th edition of The Bluebook: A Uniform System of Citation.**
